

LIMITED WARRANTY ON LINER DOCTORS ABOVE GROUND LINER

THIS LIMITED WARRANTY GIVES THE ORIGINAL CONSUMER PURCHASER (“YOU”) SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

THIS LIMITED WARRANTY MAY ALSO BE FOUND ONLINE AT <http://www.glipoolproducts.com/warranty.asp> AND IN THE DOCUMENTATION MANUFACTURER (“WE”) PROVIDES WITH THE PRODUCT. PLEASE REGISTER YOUR WARRANTY ONLINE WITHIN TEN DAYS OF PURCHASE.

WE WARRANT THAT DURING THE WARRANTY PERIOD THE PRODUCT WILL BE FREE FROM DEFECTS IN WORKMANSHIP.

WE LIMIT THE DURATION AND REMEDIES OF ALL IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE TO THE DURATION OF THIS EXPRESS LIMITED WARRANTY.

SOME STATES/PROVINCES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

OUR RESPONSIBILITY FOR A DEFECTIVE PRODUCT IS LIMITED AS DESCRIBED BELOW IN THIS WARRANTY STATEMENT.

WHO MAY USE THIS WARRANTY? This limited warranty is extended only to the consumer who originally purchased the product. It does not extend to any subsequent owner or other transferee of the product.

WHAT DOES THIS WARRANTY COVER? This limited warranty covers defects in workmanship causing a Premium Liner Doctors liner to separate at its seam during the warranty period. Liner Doctors liners are limited to the four patterns within the LINER DOCTORS category; Aspen Creek, Willow Creek, Concord, and Lexington.

WHAT DOES THIS WARRANTY NOT COVER? This limited warranty does not cover material defects as materials used in pool liners are not produced by us. As such, any failures due to material defects are to be referred to the manufacturer of such material. In most cases, defects show up almost immediately. Mechanical damages (rips, tears, punctures) of any kind are not covered by this warranty. This warranty does not cover damage due to negligence, improper installation, wind or ice, transportation, storage, improper use, failure to follow the product instructions or to perform any preventative maintenance, modifications, unauthorized repair, improper chemical utilization, or external causes such as accidents, acts of God, or other actions or events beyond manufacturer’s reasonable control. Irregularities in printing, fading or damage resulting from acts of others, including improper handling and storage are specifically excluded. The warranty is void against shrinkage if pool is emptied; pool should be cleaned with proper filtration and chemicals.

WHAT ARE YOUR REMEDIES UNDER THIS WARRANTY? We agree, in our sole discretion, to either repair or replace a product covered by this limited warranty. This does not include any costs related to such repair, replacement, or otherwise for freight, installation, labor charges, replacement water or chemicals.

WHAT IS THE WARRANTY PERIOD? This limited warranty starts on the date of purchase and lasts for twenty-five years for CONCORD and LEXINGTON patterns and twenty-years for ASPEN CREEK and WILLOW CREEK patterns. Please keep your receipt as proof of purchase date. The warranty period is not extended if we repair or replace the product. If a defect is covered by this limited warranty, we will repair or replace the product upon receipt from you of a charge based upon a percentage of the then retail selling price according to the following schedule (if 100% coverage is not warranted, then you will be responsible for payment of the difference prior to repair or replacement):

HOW TO OBTAIN WARRANTY SERVICE? To obtain warranty service, please email help@glipoolproducts.com. You will need to provide us with your contact information, a copy or digital picture of your purchase receipt, and the product’s serial number. We will contact you with further instructions, which may include returning a cutout sample or the entire product if not already done. If the entire liner needs to be returned for further inspection, a Return Goods Authorization will be issued. If at any time the product is returned to us, the product must be in a dry, reasonably clean condition, shipped to our factory with freight prepaid, and the defect must be clearly marked with tape. An authorized employee will inspect the defect upon receipt and will notify you of our decision within two (2) weeks. If the product is not covered by this limited warranty, the sample or product will be disposed of unless we have been instructed otherwise.

LIMITATION OF LIABILITY: THE REMEDIES DESCRIBED ABOVE ARE YOUR SOLE AND EXCLUSIVE REMEDIES AND OUR ENTIRE LIABILITY FOR ANY BREACH OF THIS LIMITED WARRANTY. OUR LIABILITY SHALL UNDER NO CIRCUMSTANCES EXCEED THE ACTUAL AMOUNT PAID BY YOU FOR THE DEFECTIVE PRODUCT, NOR SHALL WE UNDER ANY CIRCUMSTANCES BE LIABLE FOR ANY CONSEQUENTIAL, INCIDENTAL, SPECIAL OR PUNITIVE DAMAGES OR LOSSES, WHETHER DIRECT OR INDIRECT, INCLUDING BUT NOT LIMITED TO LOSS OF USE OF POOL OR INJURY TO PERSONS OR PROPERTY.
